PROCUREMENT NOTICE

Hereby JSC «CONCERN TITAN-2» invites you to participate in procurement procedure for **Supply of welding materials by ERICO.**

1. **Method of the procurement:** Request for Technical and Commercial Offers.
2. **The purchase is carried out** in accordance with the Regulations on Procurement in the Organizations of the Titan-2 Holding. Procurement is not regulated by Federal Law No. 223-FZ of July 18, 2011 “On Procurement of Goods, Works, Services by Certain Types of Legal Entities”.

5. **Scope of supply:** welding materials, molds.
6. **Maximum price of the contract:** 1 141 576,26 RUB excl. VAT
7. **Terms and place of the delivery:** DDP (Incoterms 2010), The construction site El-Dabaa NPP (area of El-Dabaa, Marsa Matruh Province, Arab Republic of Egypt), delivery terms different from the specified is allowed. In the case of alternative terms of supply, the participant must enclose volume-weight characteristics of the goods with the techno-commercial offer.
8. **Delivery time:** 30.12.2023.
9. **Requirements for the conditions for the execution of the Agreement:** according to the Draft of the Contract.
10. **Official language of the procurement:** Russian or English.

All documents within the Offer shall be translated to English or Russian.

11. **Currency of the procurement:** Egyptian pounds (EGP) / Dollars (USD) / Russian Rubles (RUB).

The participant's offer price is set in Russian rubles / Egyptian pounds / US dollars without VAT.

If a participant's application is sent in a currency other than USD, EGP or RUB, the price of the application is recalculated on the closing date for accepting applications at the rate of the Central Bank of the Russian Federation (<https://www.cbr.ru/>) on the corresponding date.

If the application is submitted in a currency for which the exchange rate of the Central Bank of the Russian Federation is not set, the recalculation is carried out on the basis of publicly available information from the national issuing bank of such currency about the exchange rate of this currency to the US dollar

12. **The purchase is carried out** on the "Fabrikant" electronic trading platform (ETP) on the Internet at the address: www.fabrikant.ru in the manner prescribed by the regulations of this ETP in accordance with the conditions and requirements of the procurement documentation.

Via ETP:

- the participant must obtain accreditation at the ETP in accordance with the rules, conditions and procedure for accreditation established by this ETP, and submit an application for participation in the procurement within the time period specified in this notice of procurement

OR

13. **The procedure for obtaining procurement documentation:** Procurement documentation is in the public domain, starting from the date of official publication. The procedure for obtaining procurement documentation at the ETP is determined by the rules of this ETP.

14. **Competitive negotiations** are possible.

15. **Counter-bid** is possible.

16. **Submission of alternative offers:** according to Specification.

17. **Offer submission deadline:** December 11, 2023 (by 15:00 Moscow time +3GMT).

18. **The procedure for requesting proposals is not a tender under the laws of the Russian Federation.**

19. **The notice of cancellation of the purchase** is signed by the head of the organizer and placed by the organizer on the ETP on the day the decision is made.

20. **Legal status of the documents:** This procedure is not a way to conclude the Contract at the bidding. This procedure is also not a public promise of an award or a public competition. Thus, this procedure does not impose on the Customer the corresponding volume of civil obligations. In view of this, the Customer cannot be forced to conclude an Agreement based on the results of the request for proposals.
